3. All rates are in DKK excluding VAT.
4. The rates are for berthing/shifting/sailing. The duration of assistance will count from the actual commencement of the job, or the time ordered for the job, whichever is the earliest, until the tug(s) is disconnected or released by the towage object, whichever is the latest.
5. All rates in the tariff apply 24/7.
6. Waiting surcharge is applicable when a tug has been ordered and ready, but unable to provide the service because it is kept waiting. This surcharge is payable independently of tug waiting in tug's station, en-route or alongside towage object and irrespectively of whether the total time of assistance is less than the maximum time duration.
7. Additional time surcharge is applicable if the service takes longer than the allowed maximum

time duration.

8. Two tugs of approx., 15 tons BP each are normally available in the port. Assistance with other tugs must be ordered for a firm time with 24 hours notice.
9. Firm orders can be placed during 07:00-18:00 hours on workdays with a minimum 4 hours notice before the firm time ordered for the job if the job involves local tugs. Firm orders placed at all other times require 8 hours notice. For other tugs than local tugs the same applies but 4 (8) hours to be replaced by 12 hours.
10. A start-up rate will be charged for tug orders, where it applies, that are cancelled within the time limits stipulated in clause 9.
11. Dead ship surcharge is applicable when services (whether secured with towline or not) are provided to vessels, not in distress, without normal main engine power and/or without steering within port limits.
12. Rates and terms for special services are available on request.
13. All services rendered by Svitzer, salvage services excluded, shall be subject to United Kingdom Standard Conditions for Towage and Other services (revised 2024) ("UKSCT").

14. All orders received are subject to availability. Maximum notice remains in the interest of all concerned.

- lines are to be as per industry best practice. Lack of weight will be rectified with a Svitzer safe heaving line weight. Heaving line weights deemed unsafe will be removed and replaced with a Svitzer safe heaving line weight. Svitzer reserves the right to impose a penalty for unsafe heaving lines.
19. A fuel surcharge may be applicable. Details of calculation method and surcharge amounts appear on the Europe Fuel surcharge table.
  20. Payment for all services is due and shall be paid within 14 days of the invoice date without any discount, deduction, set-off, lien, claim or counter-claim. Invoices outstanding after 14 days are subject to an interest rate of 10% per annum. (a) The agreement between the Tugowner and the Hirer is and shall at all times be subject to and include each and all of the conditions herein-after set out.
